

ORKNEY SASINES.

Edward Stewart, natural son of Robert, Earl of Orkney, in the tenandry of Brugh, South Ronald-say.

1. At Kirkwall, 1st September 1617, is registered a Sasine dated 20th August 1617, given by Edward Inksetter in Burweik as sheriff in that part to Edward Stewart, natural son of the deceased Robert, Earl of Orkney, proceeding upon a PRECEPT from CHANCERY narrating that the deceased George Stewart, natural son of the deceased Robert, Earl of Orkney, and Edward Stewart, also his natural son, and heir of provision of the said George, were heritable tenants and vassals of Patrick, sometime Earl of Orkney, and his predecessors, in the lands following which are now in the King's hands by reason of the forfeiture of the said Patrick, Earl of Orkney, for lese majesty; and in terms of the acts of Parliament for securing in their lands the vassals of those persons convicted of such a crime who were not accomplices therein, granting to the said Edward Stewart, as brother and heir foresaid, the 18d, lands of Silliebuster with the towmells thereof commonly called Peterkirkbrek, and Scharpay, with the scatland of the Gardemales otherwise called Mariekirk, 18d. lands of Scabray, with the towmells thereof, 18d. lands of Langtas in Sellibuster, with the 16d. lands of Arstis, the 8d. land tilthe alias Kingis land, with pertinents, all lying in the island of Sanday and parish1 thereof; also the 3d. and a farthing land called Wydwall benorth the burn, with five merks of utheall land in the town of Brakis, and six merks of King's land there; the 71d. lands of Brugh with the pertinents, in the island of South Ronnaldscha: the 6d. lands of Tingwall in the parish of Rendell; the 6d.

lands called lie Grind Bishop's land, with the pertinents, in the parish of St. Ola, Mainland and sheriffdom of Orkney; the lands of the Bull of Brugh in Sanday extending to 18d. lands; the 51d. lands in Hermonsgarthe there, and 7½d. lands in Symbuster there, all King's land. with the pertinents. All these lands formerly belonged to the said Edward Stewart and the deceased George Stewart his brother, held of the said deceased Patrick. sometime Earl of Orkney, and of the foresaid Robert. Earl of Orkney, his father, and they are now of new granted to the said Edward Stewart as above, and erected into a free tenandry called the tenandry of Brugh, of which the principal messuage is appointed to be on the 71d. land of Brugh in South Ronnaldschay, where Sasine may be taken for all the other lands. The Precept is dated at Edinburgh 30th March, 1616; and Sasine is accordingly taken at the foresaid messuage in presence of these witnesses, Matthew Sinclair in Brugh, David Stewart, brother of the said Edward Stewart, Patrick Mowat in Linkleter, Edward Irland in Lyquoy, William Gray in Lawlie, Magnus Gariauch, son of Nicolas Gareoche in Kirkwall, and Andrew Gadie, servitor to David Heart, of the diocese of St. Andrews, who is notary.

Malcolm Mowat in Sangar in Stronsay, in $1\frac{1}{4}$ farthing land in Knarstane in Rowsay, and $1\frac{1}{2}$ farthing land there.

2. At Kirkwall, 8th September 1617, is registered a Sasine dated 27th August 1617, given by Robert Stewart, wright in Kirkwall, as bailie, to Matthew Murray, indweller in Kirkwall, as attorney for Malcolm Mowat in Sangar in Stronsay, on a CHARTER to the said Malcolm and his heirs and assignees irredeemably granted by Robert Hamiltoun, son and heir of the deceased John Hamiltoun in Faray, of a 1½ farthing land lying in Knarstane in Rowsay, with the pertinents, sold and disponed to the said deceased John by the deceased Eliza-

beth Dick with the consent of the deceased John Craigie. her spouse, and William Craigie, her eldest son, heritable titulars thereof; also a 11 farthing land in the said town in Knarstane in Rowsay, disponed by the said Robert Hamiltoun to Gilbert Blak in Faray and disponed to him [Hamilton] by Andrew Sabistane and Elizabeth Craigie his spouse, sometime heritable titulars thereof. The Charter is written by Gilbert Doonet, and dated at Kirkwall 10th November 1614; witnesses, Harie Stewart, apparent of Gramesay, Patrick Stewart his brother, and Hew Sinclair, son of James Sinclair of Maill. signed by the said Robert Hamilton, and also for the said Gilbert Blak by David Heart, notary. Sasine is taken on the ground of the "said thrie farding land in Knarstane" at 7 a.m.; witnesses, Robert Menteithe of Egilscha, Andrew Dingwall, his servitor, and Edward Alschunder in Knarstane, John Yorstoun, John Clerk, David Leask, Magnus Smythe, all indwellers in Kirkwall, and Andrew Gadie, servitor to the said David Heart, of the diocese of St. Andrews, who is notary.

Patrick Stewart, son of James Stewart, of Gramsay, in 2½ merk land in Irland, Stanehous.

3. At Kirkwall, 14th October 1617, is registered a Sasine dated at Irland in the parish of Stanehous, 23rd August 1617, given by James Menteithe, as bailie, to Patrick Stewart, lawful son of James Stewart of Gramesay, personally, on a CHARTER by Magnus Lowtit in Bea, to him and his heirs irredeemably of his $2\frac{1}{2}$ merk land, with houses and pertinents, lying in the said town of Irland, for a certain sum of money, to be held of the immediate superiors thereof or of the said Magnus and his heirs at the option of the said Patrick for yearly payment of the scatis and other accustomed duties, with 1d. Scots on Whitsunday even on the ground of the lands if required only. The Charter is dated at Claistrene, 23rd August, 1617; witnesses, Andrew Murray, Oliver Gude and James Skaitheway. Sasine was given upon one of

the rigs of the said land and within the house pertaining to the said land, about I p.m.; witnesses, John Willox, James Skethowie, and Thomas Firth. William Fermor of the diocese of St. Andrews is notary.

Alexander Flet in How, and Hallow Flet, his spouse, in \(\frac{1}{4}d\). land in Nether Brugh, \(\frac{1}{4}d\). land in Bea there, and \(\frac{1}{6}d\). land in Brugh, Harray.

4. At Kirkwall, 15th October 1617, are registered three Sasines, all dated 10th August 1617, and all given by Magnus Sinclair in Gorn, as bailie, to Alexander Flet in How, personally, of the lands following, (1) proceeding on a CHARTER by Andrew Flet in Redland to him irredeemably of his farthing udal land in Nether Brugh, with houses and pertinents, in the parish of Harray, Mainland and shire of Orkney; which Charter is dated at Kirkwall 5th August 1616, witnesses being James Midhous, Magnus Howrie, and Robert Flet in Ramisgairth. Witnesses to this Sasine were Andrew Linkleter in Bea. Andrew Flet in Nether Burgh, Andrew Flet, younger there, and Magnus Sinclair in Ovirbrugh, and others: (2) Proceeding on a CHARTER by John Hourstane in that Ilk in favour of the said Alexander and Hallow Flet. his spouse, and their heirs, of his one farthing land in Bea lying in Nether Brugh in the parish of Harray; which is dated at Kirkwall 6th December 1616, witnesses thereto being Oliver Houstoun in Evie, John Diksone in Kirkwall, William Covintrie there, and John Robiesone, messenger, and Arthur Sinclair in Kirkwall. witnesses to the Sasine are as above: (3) Proceeding on a CHARTER of WADSET by William Brugh in Harray for wadsetting to the said Alexander and his said spouse and their heirs his halfpenny land in Brugh beside St. Mitchellis kirk in Harrow, in the parish of Harray; dated at Kirkwall 25th April 1617, and written by James Jack. notary, who also signs for the granter, who cannot write: witnesses thereto being Hew Sinclair, merchant in Kirkwall. Alexander Baxter, armourer there, John Diksoun

there, Thomas Traill there, and others. Witnesses to the Sasine were James Sinclair in Essinquoy, William Tailyeour in Ovirburgh, Magnus Sinclair there, William Andersone there, and Robert Rusland there. The notary to all the above Sasines is James Jack of the diocese of Orkney.

Hew Harray, son of David Williamson, indweller in Vailyie in Harray, in seven settings mailling malt there.

5. At Kirkwall, 16th October 1617, is registered a Sasine dated 30th September 1617, given by James Smyth in Turmistoun as bailie, to Hew Harray, lawful brother of James Harray, lawful son and eldest heir of the deceased David Williamsone (sic), sometime indweller in Vailyie in the parish of Harray, personally upon a CHARTER "by the said James Harray to his lawful brother James and Hew Harrayis" of his whole right to the seven settings mailling malt to which he succeeded after the death of the said David, his father, lying in the town of Vailvie, in the parish of Harray. The Charter is dated at Simbuster 5th July 1614, written by Alexander Bruce, notary public in Zetland; witnesses being Robert Huntar in Isbuster in Quhailsay, George Work in Clait, Robert Flett in Fetlar, Andrew Younster in Simbuster. and Gavin Ewinsoun in Weitfurd in Orkney. Witnesses to the Sasine are Thomas Cleustane in Forsabrek, Richard Lina in Grymestoun, Andrew Lina in Nethir Grymestoun, Thomas Corstane in Hormens quoy, and Patrick Smyth, brother to the said James Smyth. Robert Coltart of the diocese of Glasgow, is notary.

Hew Harray alias Davidson, in Vyilie in Harray, in $2\frac{1}{2}$ settings mailling there.

6. At Kirkwall, 16th October 1617, is registered a Sasine dated 30th September 1617, given by James Smyth in Turmistoun as bailie, to Hew Harray alias Davidsone,

brother to James Harray alias Davidsone, second lawful son of the deceased David Symonsone (sic) of Vyilie in Harray, on a CHARTER by the said James Harray alias Davidsone to the said Hew his brother, irredeemably, of his 21/2 settings mailling in Vailye in which he succeeded his father, in the parish of Harray. The Charter was dated at Weddersta, 3rd September 1616, written by David Heart, and witnesses thereto were. John Gifhert, apparent of Woddersta, Patrick Sandis, servitor to Mr. Harie Aitkin, commissary of Orkney, Magnus Olasone Lovnesetter, and John Reid, servitor to the said David Heart. Witnesses to the Sasine are Thomas Cloustane in Fortabrek, Richard Linay in Grimestoun, Andrew Linay in Nethir Gremestoun, Thomas Corstane in Houersquoy, and Patrick Smyth, brother to the said James Smyth. Robert Coltart of the diocese of Glasgow is notary public.

James Fea, apparent of Clestrain, and Margaret Sinclair, his spouse, in $2\frac{1}{2}d$. lands of Woxseter, and others, in Cross parish, Sanday.

7. At Kirkwall, 20th October 1617, is registered a Sasine dated 22nd October 1617, given by Robert Elphinstoun of Hammegar as bailie, to James Fea, apparent of Claistren in Stronsay, and Margaret Sinclair, his spouse, on a CHARTER by John Grot of Tresnes to them and their heirs, of his three halfpenny land in Woxseter with the towmell thereof, and a penny land in Gairthe and Lambnes, the townells of Gorne, Skea, Geabuster and Seater, all lying in the island of Sanda, Cross parish thereof, and shire of Orkney, under reversion. Charter is dated at Kirkwall, 17th November 1615, witnesses being William Hair, minister at Schapinscha. Robert Fea in Strensa, John Brown, messenger, and James Jack, notary public, writer thereof. Witnesses to the Sasine are William Burgar in Holland, Brandein Scott in Gradela, Thomas Angusone in Stronsa, Brandine Scott in Houssa, William Fothringham in Lepnes, and

Andrew Skae in Seater. Robert Coltart of the diocese of Glasgow is notary.

Magnus Taylor, portioner of Over Sanda, in 4 meals mailling of land there.

8. At Kirkwall, 3rd November 1617, is registered a Sasine dated 30th October 1617, given by Edward Potinger, skipper in Kirkwall, as bailie, to Magnus Tailyeour, portioner of Ovir Sanda, on a CHARTER by David Kincaid of Yinsta, with consent of Janet Duncane, his spouse, to him of two kyis worth of land extending to four meals mealling in landmeals, with the pertinents, lying in Ovir Sanda, in the parish of St. Andro, Mainland, and presently occupied by the said Magnus; under reversion. The Charter is dated at Ovir Sanda and Zinsta 30th October 1617, written by Robert Kae, notary; witnesses, Edward Potinger, skipper, the said Robert Kae, Oliver Stove in Stembuster, David Yule, mason, Robert Papla, servitor to the said Magnus, Patrick Kincaid, natural son to the granter, and Andrew Harvie, the granter's servitor. Witnesses to the Sasine are Oliver Stove in Stembister. David Zule in Kirkwall, and Robert Paipla, servitor to the said Magnus. The said Robert Kae of the diocese of St. Andrews is notary.

Charter by David Kincaid of Yinsta to Magnus Taylor, portioner of Over Sanda, of the above subjects, in Wadset.

9. At Kirkwall, 3rd November 1617, is registered a CHARTER by David Kincaid of Yinsta, whereby having borrowed from Magnus Tailyeour, portioner of Ovir Sanda, the sum of £100 Scots money, he with consent of Janet Duncane, his spouse, liferenter of the lands, sells and wadsets to the said Magnus his two kyis worth of land extending to four meals mealling in landmealls, with the pertinents, in Ovir Sanda in the parish of St. Andro, Mainland, presently possessed by the said Magnus, who is to hold the same of him for 1d. Scots yearly if

asked only and relieving him of the scats, teinds and other duties and due services in use to be paid yearly to the superiors; under reversion for the above principal sum which may be paid in two equal portions at two consecutive terms, with clause of warrandice. Precept is directed to Edward Potinger, mariner in Kirkwall, for giving Sasine; and the Charter is dated and attested as narrated in the foregoing Sasine [No. 8].

William Cursettar in Fea and Agnes Millar, his spouse, in $3\frac{1}{4}d$. land called Fea, Canigill, and Clova, St. Ola parish.

10. At Kirkwall. 20th November 1617, is registered a Sasine dated 18th November 1617, given by Harie Spens in Scapay, as bailie, to William Cursettar in Fea, personally, and to William Gordoun, merchant in Kirkwall, as attorney for Agnes Millar, wife of the said William Cursettar, on a CHARTER by William (sic) Chalmer of Ryssay, to him and Agnes Millar, his spouse, and their heirs, of his 3d. land and a farthing land called Fea, Canigill and Clova, in the parish of St. Ola, Bishopric and Mainland of Orkney, under reversion. The Charter is dated at Kirkwall, 10th November 1617, written by James Jack, notary public; witnesses, Arthur Sinclair in Kirkwall, David Forbes, the granter's servitor, and Harie Moncrieff, notary. (Signed) Robert Chalmer of Rassy. Witnesses to the Sasine were, John Prince, merchant in Kirkwall, Thomas Robiesoun, clothier ("vestiarius") there, and John Newgar, officer. James Jack of the diocese of Orkney is notary.

Charter by Robert Chalmer of Ryssay to William Curseater in Fea and his spouse, of the above subjects.

11. At Kirkwall, 20th November 1617, is registered the Charter upon which the foregoing Sasine [No. 10] proceeds, granted by Robert Chalmer of Rassay, feuar of the lands, to the said William Curseater in Fea and his

spouse, in security of 200 merks of borrowed money. The payment of the price of redemption is to be in Sanct Magnus Kirk in Kirkwall; and Precept for giving Sasine is directed, dated and attested as before narrated. (Signed) Robert Chalmer of Ryssay.

Contract, Charter, and Sasine, Robert Chalmer of Ryssay to John Prince, merchant in Kirkwall, and Marjory Spens, his wife, in 2d. land of North Weitfurd, in St. Ola parish, &c.

At Kirkwall, 21st November 1617, are registered the Contract, Charter and Sasine following. (1) Contract dated at Kirkwall 11th November 1617, between Robert Chalmer of Ryssay on the one part, and John Prince, merchant in Kirkwall, and Marjory Spens, his spouse, on the other part, whereby for the sum of 800 merks borrowed by the said Robert from the said John, Robert Chalmer obliges himself to infeft the said John Prince and his spouse and their heirs, in security, in the two penny land of North Weitfurd, with the pertinents, pertaining to the said Robert in feu and heritage and presently in his own possession, lying in the parish of St. Ola, and in an annual rent of 44 merks upliftable from the same, and in another annualrent of 36 merks upliftable from the rest of the said Robert's "best haldin landis within the cuntrey of Orkney." For satisfaction of the first of those annualrents, the said Robert dispones and sells to the said John the yearly landmails and gersumes of the said lands, to be uplifted at the prices following, viz., ten merks in yearly gersum, four meills sufficient malt upon the malt pundler, estimated at £12 13s. 4d. yearly, and a half barrel butter in landmeals yearly estimated to £9. If these annualrents are not redeemed within three years, the said Robert obliges himself to remove with his tenants and family therefrom and put the said John Prince in possession of these lands, until the said annualrent of 44 merks is redeemed and until the bygone interest of the annualrent of 36 merks

is fully paid. The principal sum for redemption of these lands and annualrents may be paid within St. Magnus Kirk in Kirkwall. The one of the annualrents may be redeemed before the other for 400 merks; and the penalty of non-redemption is £40. The other 400 merks is then to be secured by a wadset to the said John Prince and his spouse of the foresaid lands, they uplifting the maills, duties, and gersums thereof and acquiring further possession thereof, until the lands are redeemed. The parties consent to registration in the Books of Council. Sheriff or Commissary Books of Orkney; and witnesses to the contract are, Jerome Chalmer, Thomas Robiesoun. indwellers in Kirkwall, Thomas Moncrieff there, David Forbes, servitor to the said Robert Chalmer, Robert Kaa. writer of the deed, Harie Spens in Scapa, and Robert Halcro of Cava. The said John Prince and his spouse sign (because they cannot write) by the hand of Henry Moncrieff and the said Robert Kaa, notaries. (2) Charter by the said Robert Chalmer of Ryssay in favour of the said John Prince and his spouse and their heirs, of the above lands and annualrents, in terms of the foresaid Contract. The Precept for Sasine is directed to Harie Spens in Scapa as bailie; and the Charter is dated at Kirkwall 15th November 1617, written by Robert Kaa, and attested by Robert Halcro of Cava, Harie Moncrieff and the said Robert Kaa, notaries, Thomas Robiesoun, tailor, and Jerome Chalmer, skipper in Kirkwall. Sasine, dated 18th November 1617, given to the said John Prince personally and to William Gordoun, merchant in Kirkwall, as attorney for the said Marjory Spens. by the said Harie Spens in Scapa, as bailie, proceeding on the foresaid Charter, of which the precept is here again narrated. They took Sasine at the house of the said Robert Chalmer on the ground of the lands of North Weitfurde, in the presence of witnesses, James Jack. notary public, Thomas Robertsoun, weaver, Archibald Das and John Newger, indwellers in Kirkwall. Robert Kaa of the diocese of St. Andrews is notary.

- Contract, Francis Mudie of Breknes and Magnus Brown in Uttertown of Stromness, about lands in Leager in Uttertown.
- 13. At Kirkwall, 21st November 1617, is registered a Contract made at Kirkwall 14th December 1617, between Francis Mudie of Breknes and Magnus Brown in Uttertown of Stromnes, whereby the latter renounces the three merk uthall land in Leager in the Uttertown of Stromnes and third part of a merk uthall land under the house of Ovirdone, with their pertinents, in the parish of Stromnes, sometime sold and disponed to the said Magnus Brown by William Sinclair, lawful son of Alexander Sinclair in Done; for which cause the said Francis Mudie sets in tack to him his six merk and third part of a merk of land in Leager in the Uttertown of Stromnes conquest by him from the said Magnus Sinclair (sic) with the house of Nethirdone, and the towmeale lying about the same, during the lifetime of the said Magnus. The tack duty is three meills two settings good and sufficient Orkney malt, and relieving the said Francis of the scat and teind yearly, and is to be paid between 1st January and last of February yearly. The contract is written by David Heart, writer, and the witnesses thereto are, Edward Stewart of Brugh, David Stewart, his brother. Malcolm Mowat in Sangar, Andrew Leask in Grundwater, the notary, and John Neven, his servitor. Magnus Brown being unable to write signs by the aid of the said David Heart, and James Jack, also notary.
 - John Foubuster, in 2½ cow's worth of land in Foubuster in St. Andrews, and a setting mailling in Sandis in Deerness.
- 14. At Kirkwall, 22nd November 1617, is registered a Sasine dated at Foubuster within St. Androis parish, 8th November 1617, given by Andrew Foubuster, as bailie, to John Foubuster, proceeding upon a BOND and OBLIGATION granted by Richard Foubuster to the said

12 1617.

John Foubuster, his brother german, acknowledging receipt of a loan of £9 10s. Scots money besides £25 which he has lying upon the said Robert's (sic.) two kyis worth of land and the fourth part of a kowis worth lying in the said town of Foubuster in the parish of St. Androis with a setting mailling more in the town of Sandis in the parish of Deirnes, and in case the said £9 10s. is not paid by the said Robert to the said John by Lammas day this year, the said land is to become heritage to the said John and his heirs for ever. The bond is dated at Hurteso in Holme 13th May 1617; and Sasine was given by the bailie taking up "stane and muld of the grund of the said land of Foubuster to serve for the rest of the said land of Deirnes" and delivering the same to the said John Foubuster. Witnesses to the Sasine are, Malcolm Foubuster, Nicoll Okilsetter, and Abel Foubster (sic). William Fermour of the diocese of St. Andrews is notary.

Robert Halcro of Cava, in 3 merk land in Fea in Stenness, lands in Cloustane and Rusland, 2\frac{2}{3} merk land in Irland, and half of the six merk land in Bea there.

15. At Kirkwall, 26th November 1617, are registered the following four Sasines, all dated 22nd November 1617, and given by William Hannay in Evie, as bailie, to Robert Halcro of Cava, personally. (1) Proceeding on a CHARTER by William Corrigill in Huntiskart in Harray to the said Robert and his heirs and assignees irredeemably of the three merk land with pertinents lying in Fea in the town of Irleand and parish of Stanehous; which Charter is dated at Kirkwall 10th November 1615; witnesses, Captain Thomas Knichtsone, Edward Ingsettar, reader, Thomas Auchinleck, William Fermour, notary public, and writer thereof, and James Jack, notary, both of whom assist the granter to sign because he cannot write. Witnesses to the Sasine are, Hugh alias Hay

Lutit in Bigiswell, William Unstoun in Unstoun, John Leask in Cloustane, William Leask there, Robert Germistoun in Germistoun, and Peter Loutit in Ottirgill. (2) Proceeding on a CHARTER by Magnus Braik in Papa Westra, lawful son and heir by succession to the deceased Gilbert Brack and Katherine Housland, uthellars and heritors of the lands following, to the said Robert Halcro and his heirs and assignees, of his one meals mealling of land in Cloustane in parish of Stanehous, and half meills mealing of land in Rusland in parish of Harray, irredeemably; which Charter is dated at Kirkwall 5th November 1616, written by James Jack, notary, who also signs in behalf of the granter, seeing he cannot write, and witnesses are. Thomas Mane, merchant in Kirkwall, Henry Stevinsoun, merchant there. Oliver and Robert Feas, brothers german. Witnesses to this Sasine are Hugh alias Hay Luttit in Bigiswell, William Unstoun in Unstoun, John Leask in Cloustane, George Henrie there, and John and Robert Braiks there. (3) Proceeding on a CHARTER and DISPOSITION by Katharine Ramsquoy with consent of James Leask, her spouse, to the said Robert and his heirs and assignees of a two merk land and two part merk land, with the pertinents, in the town of Irland and parish of Stanehous, irredeemably; dated at Kirkwall 22nd June, 1617, witnesses, William Carmichaell, merchant, John Gardaner, wright, Thomas Moncrieff, merchant, indwellers in Kirkwall, and Thomas Firth in Irland. Hay and Robert Germestoun, brothers, in a farthing land in Germestoun, in the parish of Stenness.

58. At Kirkwall, 22nd April 1619, is registered a Sasine dated 24th March 1619, given by Robert Bankis

in Germestoun, as bailie, to Hay and Robert Germestounes, brothers german, on a CHARTER by James Hay alias Germestoun, lawful son of the deceased David Hay alias Germestoun, to them of his one farthing land in Germestoun, presently occupied by James Jonstoun in Germestoun by right of the deceased William Halcro, lying in the parish of Stanehous; which Charter, dated at Kirkwall 17th March 1619, is attested by Arthur Sinclair in Kirkwall, Thomas Moncreiff, merchant there, and Allester Lyme braibner. Witnesses to the Sasine are, Magnus Howrie, indweller in Redland, Andrew Flett there, Cristie Burweek there, and John Flett there. Robert Scollay of the diocese of Orkney is notary.

Contract between Robert Menteith of Egilsey, and others, and William Colville, of Midhous, and others, about the lands and isle of Egilsey.

70. At Kirkwall, 14th July 1619, is registered a CONTRACT (with Renunciation therein) dated at Edinburgh 4th June 1619, made between Robert Menteithe of Egilschaw, for himself and taking burden for Edward Alexander, indweller in Knairstane in the Isle of Rowsay in Orkney, and also for all his tenants indwellers in the Isle of Egilschaw, on the one part, and William Colwill of Midhous, for himself and taking burden for Katherine Douglas, his mother, and John and James Colwill, his brothers german, and all his other brothers and sisters, the sons and daughters of the said Katherine Douglas, and for the husbands and spouses of so many of her said daughters as are already married, and also taking burden for Mr. Robert Henrysoun of Holland, which

persons, viz. his mother, two brothers named, and the said Mr. Robert Henrysoun, and they alone, he is to cause subscribe this contract, and James Colwill of Balbedie, cautioner for the said William Colwill, on the other part, whereby the said parties taking burden as above ratify a former Contract made at Edinburgh and Kirkwall, 22nd June and 3rd November 1616, between them in all points except where hereafter altered or discharged. On 16th July 1618 the said William Colwill of Midhous raised a process of apprising against the said Robert Menteith, Hew Halcro of that Ilk, Hew Halcro of Aikeris, Thomas Swintoun, minister at Birsay, and Edward Stewart of Brughe, whereby there was apprised in his favour the ground right and property of the lands and isle of Egilschaw extending to an 18d. land, with the holm called Kiddieholme (sic) and the mill, mill-lands, multures, &c. thereof, with the office of bailiary thereof, and the teindsheaves, all in the parish of Rowsay, for payment to the said William Colwill of the sum of 4115 merks of principal due by the said Robert Menteith for himself and as cautioner for the said persons mentioned in the process, and for the sum of 205 merks and 10 shillings of sheriff fee; and thereupon he obtained a Charter under the Great Seal, of these lands, but has not yet taken Sasine. Wherefore, and for the sums of money above written and the due interest thereon now paid to him by the said Robert Menteith, the said William Colvill renounces and discharges the foresaid process of apprising and the Charter granted to him of the said lands and isle in favour of the said Robert Menteith, reserving right to the latter to proceed against the other persons foresaid for whom he was cautioner for their proportion of the debt. Likewise the said William Colvill acknowledges himself satisfied of certain bonds which had been granted by the said Robert Menteith, both as principal and cautioner aforesaid, in his favour and which were assigned by the said William

to Mr. Robert Henrysoun of Holland, who raised letters against the said Robert Menteithe for payment, but for whom the said William Colvill now takes burden. by another CONTRACT dated at Kirkwall, 5th December 1616, made between the said Robert Menteith and William Colvill, the former set in tack to the said William the half of the town and lands of Kirbuster in Egilschaw, with the houses and pertinents, and also set in labouring to the said William, as grieve to him, the other half thereof for the crop and year 1617, on payment of the duties. etc.. contained in the said Contract, and under a condition that the said William would remove within a certain time now past; yet he has not removed, but has sown these lands in this year 1619. Now, however, he renounces the said tacks and promises to remove from the lands, ceasing to pasture his cattle thereon and taking away his stuff by the 26th of June instant; "lykeas for transporting of the said William Colwills haill horses, meiris, ky, oxin, guidis, geir and plenisching perteining to him as yit extant within the said Ile of Egilschaw and houses thairof, it is aggreit upoun betuixt the saidis pairties that said William Collwill sall furnesche boittis, and the said Robert Menteith sall furnesche serwands, for carreing and transporting of the samen furth of the said Ile, and sall put the said Williams horses, meiris, ky and oxin to the schoir of Aikernes, and the said Williames scheip with his uther geir and plenisching to the schoir of Midhous," there to be dealt with at the said William's pleasure; and the said William is to bear the hazard of transporting the said substance by the sea. If any difference arises between parties as to the ownership of the actual goods and plenishing taken away, all is referred to the arbitration and inspection of Patrick Smyth of Braiko, or, if he is absent from Orkney, George, Bishop of Orkney, so that no more than the said William's rightful property may be transported. Failing the said William's furnishing of boats and trans-

porting these goods by the day above fixed, it shall be lawful to the said Robert Menteith immediately thereafter to cause transport the cattle and goods foresaid from the said lands and isle of Egilschaw and put them on shore on the Mainland at Burgar in Evie in Orkney, and then be no further answerable anent his intromission or delivery thereof. Particular reference is made to "ane great locked chist" containing bedding, etc., also a brewing caldron, some "blewing loomes," plough graith, "quarrell" graith, &c. belonging to the said Robert Menteith and lying in the house of Kirbister, with all other goods as contained in an inventory signed by John Buchannen, servitor to his Majesty, and another inventory subscribed by Katherine Nisbet, spouse to the said Robert Menteith, all which the said William Colwill promises to leave undamaged, at the sight of the foresaid arbiters. There is an arrangement about the bear crop presently also about 27 sheep which Robert Menteith alleges were on the lands when William Colwill entered thereto, and likewise eight horses, two ky, and one ox, as to which William Colwill is content that the said Robert shall intromit with such of these as are yet to the fore, and for such as may be slain, eaten, destroyed or disposed of, he will give as good sheep, head for head and piece for piece and sheep for sheep, and replace any of the horses, ky or the ox if need be. He is also owing five chalders of bear, and 57 meills four settins and a half of meal to the said Robert, who is content to accept in payment thereof two stacks standing in the cornyard of Kirkbuster, one of bear and the other of oats, after the same have been "cassin to pruiff" by James Flatt in Evie and Magnus Mainland in Weare; the surplus, if any, due by the said William being handed over by him to the said Robert either on the Isle of Egilshaw or in the town of Kirkwall before 20th July next, otherwise £60 scots for each chalder of bear and £4 for each meill of meal before 1st August. Further, the said

William Colvill obliges himself to deliver to the said Edward Alexander as many "brod geese" as the foresaid arbiters shall ascertain to have been shot or slain by the said William or his brothers or followers will also restore to the tenants of the said Robert Menteith any hagbuts and armour taken from them by him or his followers, or pay the value thereof. And he, taking burden for his said mother, brothers and sisters aforenamed, renounces an action of ejection and spoliation raised against the said Robert Menteith, Edward Alexander, Gilbert Mowat in , John Yairstoun in Egilschaw and others, for putting him furth of the said lands of Kirbuster and Egilshaw, and also all other processes at law referring thereto. This agreement is not to prejudge or include an assignation made by William Ballenden of Gairsev to the said William Colvill on . . . February 1615 (registered in the Books of Council . . . June 1616) of a letter of reversion granted by the said Robert Menteith to him of the lands and isle of Gairsay and all other lands, isles, and subjects, sold and disponed by the said William Ballenden to the said Robert, which letter is dated 30th June 1612; nor a Backbond and Obligation by the said Robert to the said William Ballenden upon the surplus of his rents and duties of the said lands beyond what is payable as annualrent upon the sum of 12,500 merks for which the lands were mortgaged, which Backbond is dated 30th June 1612. For his part, the said Robert Menteith not only has paid a large sum of money to the said William Colvill, but he and the said Edward Alexander both with one consent hereby renounce an action of ejection and spulzie raised by them against the said William, John Colvill, his brother, and their accomplices, anent the taking away and appropriating of cattle and goods out of the said lands of Kirbuster and Egilschaw, manor place of Howen, and the rest of the lands of Egilschaw: and all other actions and processes between parties are hereby discharged.

the said Robert Menteith shall happen to be out of Orkney at any of the times of the delivery of goods, victual, etc. by the said William Colwill as above appointed, it shall be lawful for the said William to deliver the same to Thomas Main, burgess of Kirkwall, whose receipt shall be given therefor. The parties consent to registration hereof in the Books of Council. The Contract is written by James Hardie, servitor to John Gilmoir, writer; and witnesses thereto are John Buchannan, servitor to his Majesty, Mr. William Levingstoun, brother german to Patrick Levingstoun of Daldeif, Robert Elphinstoun of Hamegar, Thomas Wricht, indweller in Leith, and the said James Hardie. John Gilmoir and James Neven, notaries, assist Edward Alexander, who cannot write, to subscribe the deed.

James Scollay of Tofts, in the Isle of Papa, Stronsey, the Bull of Tofts, and lands of How.

71. At Kirkwall, 25th August 1610, is registered a Sasine dated 21st July 1610, given by Henry Stewart, sheriff depute of Orkney, to James Scollay, now of Toftis, son of the deceased David Scollay of Toftis, on a CROWN PRECEPT from CHANCERY directed to the sheriff of Orkney and his deputes for giving Sasine to the said James Scollay, as heir to his said father, in the Isle of Papa Stronsa, being a 12d. land, in the parish of St. Peter there, and in the Bull of Toftis extending to an 18d. land, and 8d. lands in How adjacent thereto, lying in Northwall in the parish of the Blessed Virgin Mary in Sanda, which lands were formerly held of the deceased Robert, Earl of Orkney, and now are held of the Crown in feufarm and heritage on account of the forfeiture of the deceased Patrick, Earl of Orkney, brother and heir of the deceased Henry Stewart, fiar of Orkney. eldest son of the said deceased Robert, Earl of Orkney, The lands have been in nonentry for 26 years and one

At Kirkwall, 25th August 1619, is registered a Sasine dated 21st July 1619, given by James Scollay of Toftis with his own hands to Matthew Mowbray, indweller in Kirkwall, as attorney for Jean Henrysoun, spouse to the said James, on a CHARTER by him to his said wife in liferent of his 18d. land in Toftis in Sanday. 16d. land in How benorth there, with the pertinents, in the isle of Sanday, Lady parish thereof; and of his 12d. land of Papa Stronsay lying in St. Peter's parish of the said Isle of Stronsay; which Charter is dated 6th July 1600 (sic). Sasine is taken on the various lands exactly as in the preceding (No. 71), in presence of Harry Stewart, sheriff depute of Orkney, John Hendirsoun of Weyland, Thomas Ramsey, merchant burgess of Edinburgh, Robert Coltart, notary public, David Keldall and Thomas Angusone, boatmen in Kirkwall, Malcolm Scollay, son of the said James Scollay, and Patrick Sandis, servitor to the notary, Mr. Henry Aitken.

John Irvine in Copinsey, in a two merk land in Scy in Deerness.

73. At Kirkwall, 26th August 1619, is registered a Sasine dated 27th July 1619, given by William Watt, indweller in Kirkwall, as bailie, to John Irwing in Cobinschaw, on a CHARTER of WADSET and DISPOSITION by Henry Colsetter, indweller in Kirkwall, to him of his two merkland, with houses and pertinents, lying in the town of Scy^1 (sic) in the parish of Deernes, under reversion for £43 Scots money; and his tenement of land with the yard and pertinents thereof presently occupied by himself lying in the Midtoun of Kirkwall on the east side of the "hie gait" thereof, in warrandice of the above subjects. Precept is directed to John McKenzie and the

said William Watt as bailies. The Charter is written by William Fermour, notary public, and dated at the Newark in Deernes, 23rd March 1619; witnesses being John McKenzie, Magnus Cragie in Colseter, George (sic) in Newark, and George McKenzie. Witnesses to the Sasine are, Hew Sinclair of Zairsay, Edward Potinger, skipper, James Baikie, merchant, indwellers in Kirkwall, and James Midhous in Evie. Renunciation by Jean Stewart, daughter of James Stewart of Graemsey, to her husband, Hew Halcro of that Ilk, of right to the mill of Bankis, etc.

At Kirkwall, 9th September 1619, is registered a Renunciation granted by Jean Stewart, lawful daughter of James Stewart of Gramesay, and spouse to Hew Halcro of that Ilk, mentioning that by a CONTRACT OF MARRIAGE dated at Claistren, 12th January 1615, between the said Hew Halcro and her said father on her behalf. anent their then future marriage, the said Hew Halcro promised to infeft her in liferent, and the heirs of the marriage in fee, in the lands and isle of Enhallow with the teindsheaves thereof, and his 7d. land of Brugh, Id. land in Scabra, Id. land in Pow, Id. land in Garsen, 1d. land in Widquoy, and $\frac{1}{2}$ d. land Coitquoy, ½d. land in Lilister, ¼d. land in the North town of Brugh, 3d. in Wosbuster, and the mill of Bankis and multures thereof, with all houses and yards, etc. pertaining to these lands, lying in the Isle of Rowsay; and accordingly he granted a Charter thereof to her, and Sasine was taken thereon. At Kirkwall, 15th September 1619, is registered a Sasine dated at Weidweik in the parish of Evie, 14th September 1610, given by Patrick Murray of Wedweek himself to John Spence in Nether Erweik, as attorney for Bessie Swintoun, spouse to the said Patrick, on a LIFERENT CHARTER by him to his said spouse of the 3d. land in Nethir Erweik, 3d. land in Dyk in Evie, 1d. land in Forsabrek in Costa, and 4d. land in Daill in Evie, with the pertinents, in the parish of Evie, to be held by her of the said Patrick for payment upon the lands of Nethir Erweik of 1d. Scots yearly if asked, and paying to the superior of the feu duty accustomed as contained in the original feu-charter. At Kirkwall, 10th October 1619, is registered a Sasine dated 16th October 1619, given by Hew Sklaiter in Rendall, as baillie, to Hew Halcro of Aikeris personally, and to Patrick Murray of Wedweek as attorney for Margaret Stewart, spouse to the said Hew, on a CHARTER granted to them and their heirs by James Baikie, merchant in Kirkwall, brother's son and heir of the deceased John Baikie, merchant there, of a half penny land in Gorsnes extending in yearly rent to four settings victual and four settings flesh; also of two meills mailling in Massater; and a farthing land in Hammer extending in yearly rent to half a meal victual and half a meal flesh; with houses and pertinents, all lying in the parish of Rendall. At Kirkwall, 1st November 1619, is registered a Sasine dated 26th October 1619, given by Arthur Sinclair, merchant and one of the bailies of Kirkwall, as bailie, to Edward Potinger, skipper, indweller in Kirkwall, personally, and to James Potinger, his brother, as attorney for Katherine Baikie, spouse to the said Edward, on a CHARTER by Magnus Sinclair in Gorne and Marjory Irwing, his spouse, with consent of William Irwing now of Saba, for any right he may have as heir to the deceased William Irving of Saba, his goodsir, of a tenement of land back and fore, under and above, with the yard, tail and pertinents thereof, disponed to the said Magnus Sinclair and his spouse by the said deceased William Irwing, lying in the town of Kirkwall "in that pairt thairof callit the Brugh," between the lands pertaining to the heirs of the deceased William Main on the north, the "common calsey" on the east, the houses and tenement pertaining to the heirs of the deceased Ninian Flett on the south, and the sea called the Oyse of Kirkwall on the west.
